**One, Jerry G Heffernan, declares and affirms that by my freewill act and deed Affiant, Jerry G Heffernan, executes this acknowledgement of my acceptance of the Birth Certificate #134-59-31460 and lawful ownership of the property under the terms of the deed. Affiant asks that the record on file in the Office of Secretary of State for the United States of America and the State of Ohio be updated to show my acceptance of the said certificate of origin, as lawfully seized owner of the document.**

- 2. One, Jerry G Heffernan, declares and affirms that all of Affiant's other real property and interest issued in the name of the Certification of Vital Record Birth Certificate # 134-59-31460 is to be immediately returned to the Estate.**


