WITHOUT PREJUDICE U.C.C. § 1-308 [1-207 &] 1-104 ASSEVERATION

I, junart-nabor: sodoy, sui juris, a true man of God, a private citizen, NOT a Sovereign-Citizen , do hereby exercise the remedy found in section 1 of the Uniform Commercial Code at 1-308 and 1-207 [pursuant to the construction against implied repeal at U.C.C. § 1-104]. I do hereby DECLARE and AFFIRM that I have not and will not absolve or relinquish, or in any other way surrender my God-Given, unalienable or common law right protected by the United States Constitution and State Constitution ("which emphatically states the United States Constitution is to be the Law of the Land") and the Bill of Rights of both thereunder, by word, deed, mistake or performance under any Unrevealed Contracts, Commercial Agreements which I did not enter into intentionally, knowingly and voluntarily.

This Explicit Reservation of Rights under the Uniform Commercial Code also serves NOTICE upon all Administrative Agencies of Corporate Government, be they federal, State and Local, that I have not accepted, and will not accept, the liabilities associated with a compelled benefit of any Quasi-Contract, Administrative Contracts implied at Law, implied Consent Legislation, Bankruptcy or any other trick or artifice under "color of law". NOTICE is further served upon all non-governmental organizations worldwide that I am neither a subject of, nor subject to, any actions which may emanate from these "factors of law" or superseded jurisdiction .

I declare my reverence for the Constitution of the United States of America, my respect for those who sacrificed defending its principles and my brotherly love for those who strove to maintain those principals.

Fourteenth Amendment Citizenship and Law Merchant Status is hereby publicly denied. U.C.C. 2-104



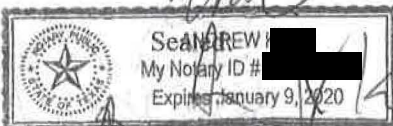
