This Hold-harmless and Indemnity Agreement is mutually agreed upon and entered into in this Twenty-first Day of the Eleventh Month in the Year of our Lord Two Thousand and Twenty Four between the juristic person: "MARK SANCHEZ" and any and all derivatives and variations in spelling of said name, hereinafter jointly and severally "Debtor"; except "Mark Anthony Sanchez" the living, breathing, flesh-and-blood woman, known by the distinctive appellation Mark Anthony Sanchez, hereinafter "Creditor".

For valuable consideration, Debtor hereby expressly agrees and covenants, without benefit of discussion, and without division, that Debtor holds harmless and undertakes the indemnification of Creditor from and against any and all claims, legal actions, orders, warrants, judgments, demands, liabilities, losses, depositions, summonses, lawsuits, costs, fines, liens, levies, penalties, damages, interests, and expenses whatsoever both absolute and contingent, as are due and as might become due, now existing and as might hereafter arise, and as might be suffered/incurred by, as well as imposed on, Debtor for any reason, purpose, and cause whatsoever. Debtor does hereby and herewith expressly covenant and agree that Creditor shall not under any circumstance, nor in any manner whatsoever, be considered an accommodation party, nor a surety, for Debtor.

Defined Glossary of Terms

As used in this Hold-harmless and Indemnity Agreement, the following words and terms express the meanings set forth as follows, non obstante:

Appellation: In this Hold-harmless and Indemnity Agreement the term "appellation" means a general term that introduces and specifies a particular term which may be used in addressing, greeting, calling out for, and making appeals of a particular living, breathing, flesh and-blood woman.

Conduit: In this Hold-harmless and Indemnity Agreement, the term "conduit" signifies a means of transmitting and distributing energy and the effects/produce of labor such as goods and services via the name, "MARK SANCHEZ", also known by any and all derivatives and variations in the spelling of said name of Debtor except all derivatives and variations in the spelling of the name of "Mark Anthony Sanchez" Creditor.

Creditor: In this Hold-harmless and Indemnity Agreement, the term "Creditor" means "Mark Anthony Sanchez" and all derivatives and variations in the spelling of the name of "Mark Anthony Sanchez CO".

Debtor: In this Hold-harmless and Indemnity Agreement, the term "Debtor" means "MARK SANCHEZ", also known by any and all derivatives and variations in the spelling of said name excepting "Mark Anthony Sanchez" and all derivatives and variations in the spelling of the name of "Mark Anthony Sanchez".

Derivative: In this Hold-harmless and Indemnity Agreement, the word "derivative" means Coming from another; taken from something preceding; secondary; that which has not the origin in itself, but obtains existence from something foregoing and of a more primal and fundamental nature; anything derived from another.

Ens legis: In this Hold-harmless and Indemnity Agreement, the term "ens legis" means a creature of the law; an artificial being such as a corporation, considered as deriving its existence entirely from the law as contrasted with a natural person.

Hold-harmless and Indemnity Agreement: In this Hold-harmless and Indemnity Agreement, the term "Hold-harmless and Indemnity Agreement" means this Hold-harmless and Indemnity Agreement No. 00084780-1 as this Hold-harmless and Indemnity Agreement may be amended and modified in accordance with the agreement of the parties signing hereunder, together with all attachments, exhibits, documents, endorsements, and schedules re: this Hold-harmless and Indemnity Agreement attached "MARK SANCHEZ ("In this Hold-harmless and Indemnity Agreement, the "MARK ANTHONY SANCHEZ" means "MARK A SANCHEZ" and any and all derivatives and variations in the spelling of said name except "Mark Anthony Sanchez"" and all derivatives and variations in the spelling of the name "Mark Anthony Sanchez", Common Law Copyright O 2023 by "Mark Anthony Sanchez" All Rights Reserved.)"

Juristic person: In this hold-harmless and Indemnity Agreement, the term "juristic person" means an abstract, legal entity *ens legis* such as a corporation, created by construct of law and considered as possessing certain legal rights and duties of a human being; an imaginary entity, such as Debtor, i.e. which, on the basis of legal reasoning, is legally treated as a human being for the purpose of conducting commercial activity for the benefit of a biological, living being, such as Creditor.
