You are ORDERED to Confirm My Right of Claim of LIBERTY; as I am over the Age of 25 and I am competent in knowledge; a Constitutional Right protected by the Laws of the Bible (Leviticus and Deuteronomy) and Treaty Law (the American - Declaration of Independence).

To Department of Treasury - Principal/Agents: (including State and County Treasurer Office holders)
