Section 1: Definitions

Ens legis:

A creature of the law; an artificial being, as contrasted with a natural person. Applied to corporations, considered as deriving their existence entirely from the law. -Black's Law 4th Edition

Public corporation:

A public corporation is one created by the state for political purposes and to act as an agency in the administration of civil government. -Black's Law 4th edition

Person:

The term "person" shall be construed to mean and include an individual, a trust, estate, partnership, association, company or corporation. -26 USC 7701(a)(1)

Taxpayer:

The term "taxpayer" means any person subject to any internal revenue tax. -26 USC 7701(a)(14)

United States:

A Federal corporation - 28 USC 3002(15)(A). *Additional note: "The United States is located in the District of Columbia." as per UCC 9-307(h)

Nation:

"An Independent body politic; a society of men united together for the purpose of promoting their mutual safety and advantage by the joint efforts of their combined strength. But every combination of men who govern themselves independently of all others will not be considered a nation. A body of pirates, for example, who govern themselves, are not a nation. To constitute a nation, another ingredient is required. The body thus formed must respect other nations in general, and each of their members in particular. Such a society has her affairs and her interests; she deliberates and takes resolutions in common, thus becoming a moral person, who possesses an understanding and will peculiar to herself, and is susceptible of obligations and rights." -Vattel, Prelim. Ill, 2; 5 Pet. (U. S.) 52. See 1 Idaho (N. S.) 612.

Peace:

The tranquility enjoyed by a political society, internally by the good order which reigns among its members, and externally by the good understanding it has with all other nations. Applied to the internal regulations of a nation, peace imports, in a technical sense, not merely a state of repose and security as opposed to one of violence or warfare, but likewise a state of public order and decorum. - Black's Law 4th Edition

state:

In its largest sense, a "state" is a body politic or a society of men. -Black's Law 6th Edition

Body Politic:

State or nation or public associations -Black's Law 4th Edition

Society:

An association or company of persons (generally unincorporated) united together by mutual consent, in order to deliberate, determine, and act jointly for some common purpose. In a wider sense, the community or public; the people in general. -Black's Law 4th Edition

Amnesty:

Amnesty is the abolition and forgetfulness of the offense. -Black's Law 4th Edition

Coalition:

a temporary alliance of distinct parties, persons, or states for joint action. -Merriam-Webster's dictionary

Section 2: Opening Statements

First and foremost, I would like to clarify that I am entirely at peace with the IRS, the Internal Revenue Service, "US GOVT" and any other DBA filings or corporate entities associated with or related to Internal Revenue.

For most of my life, I have not understood taxation and the basic ideas of nationality, location, etc. Because of this, I have taken time to truly dive deep and understand how this all works in great detail.

I have no animosity, desire for revenge or any other "feelings" associated with my relationship with Internal Revenue and I now feel like I can properly perform on all ens legis/public corporation accounts.

Section 3: Nationality Clarification

8 USC 1101(a)(23) states: "The term "naturalization" means the conferring of nationality of a state upon a person after birth, by any means whatsoever."

Through the tremendous power of naturalization, I hereby confer the nationality of the state of The Nation of the Amnesty Coalition on my ens legis, NICOLE LYNN VAN HOUTEN.

The tax treaty between The Amnesty Coalition and "United States" is very simple: there will be no taxes removed or paid under any circumstances. This line clarifies any aspect of any W-8BEN that may be submitted by myself or any other ambassador of The Amnesty Coalition. There are no citizens of The Amnesty Coalition, only ambassadors.

I attest that my ens legis has been previously born after the Dept of Health and Human Services processed my Certificate of Live Birth. I have also been born, as the agent on behalf of NICOLE LYNN VAN HOUTEN as a non-incorporated living woman. I was born on 8/19/1986 and the ens legis was born on 8/22/1986.

Myself, as the non-incorporated living agent of the ens legis, speaks on behalf of the ens legis. If a Durable Power of Attorney is also requested between myself as the natural person and ens legis, I would be more than happy to provide that. Please simply request that and I can get that to you.

In fact, one or more points of 8 USC 1408 apply to my life and, technically, myself as the agent to the ens legis, has always been a "national but not citizen" since my birth.

If I have previously conferred the nationality of the State called "United States" on myself or my ens legis, I would like to be abundantly clear that I had absolutely no idea what I was signing or conferring or attesting to and I deeply apologize for making such an ignorant mistake.

Both myself and my ens legis are (and always have been) both foreign nationals (nonresident aliens) as per 8 USC 1101(a)(21).

IMPORTANT NOTE: THIS REVOCATION OF ELECTION APPLIES ALL THE WAY BACK TO THE ORIGINAL SUPPOSED ELECTION. I MAY OR MAY NOT FILE CORRECTIONS ON PREVIOUS TAX YEARS IN ORDER TO HAVE PREVIOUS ELECTION YEARS REFUNDED AS I WAS NOT ACTUALLY A US CITIZEN OR RESIDENT ALIEN DURING ANY OF THOSE YEARS AND NEITHER WAS THE ENS LEGIS.

Section 4: Indorsement Clarification

All previous blank indorsements are hereby rescinded pursuant to UCC 3-202. From this point forward, all bills of exchange and promissory notes will have a special/restrictive indorsement (even if not written directly on the negotiable instruments) of the following:

Section 5: Closing Statements

After receipt of this Revocation of Election, neither myself nor the ens legis will be considered "taxpayers" any longer as per the definition from 26 USC 7701(a)(14). If at any time in the future I make any income specifically from the United States, I will be sure to handle that situation, as necessary, at that time. Until that occurs, please do not write to me or my ens legis using the word "taxpayer" as that would be quite improper. Please use the term "foreign friend" for all salutations.

I would also like to be clear that the ens legis is never residing at the same address of which I domicile at. If you are explicitly looking to contact the ens legis on some kind of financial matter, you may want to contact the U.S. Treasury first to handle any financial imbalances in accordance with 18 USC 8.

Thank you for all the assistance in the future that I may need with EIN numbers or anything else. I look forward to a long and prosperous relationship for the both of us and I intend on behaving in a way that accompanies my new salutation of "foreign friend."

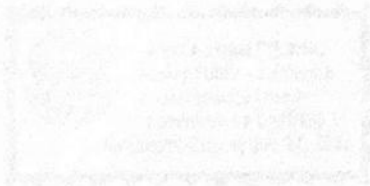
