I. PURPOSE OF THIS PATENT

Let it be known and recorded that this document brings forward the original Land Patent for the private tribal estate of Sharita Tameka Patterson, lawfully known as Asia Aura, Empress of the Born Gods Nation Tribe, and hereby returns said land to its rightful standing as allodial sovereign land, free from commercial registration, taxation, levy, or unlawful seizure.

This patent cancels and overrides all corporate deeds, mortgages, or state/county claims made under color of law. Any such claims are deemed null, void, and fraudulent ab initio.

TO THE HONORABLE COURT: I, SHARITA T PATTERSON OF FULL AGE,
RESIDING AT, [REDACTED], NEWARK, NJ 07104 AND [REDACTED]
STREET, NEWARK, NJ 07104 BEING DULY SWORN, DEPOSE AND SAY:
Sharita Tameka Patterson(Asia Aura) Affirmation of Ancestral Descent from the
Navajo Nation For Use in Asserting Sovereign Rights and Land Reclamation
Under Treaty and Constitutional Law

I, Sharita Tameka Patterson, being of sound mind and lawful capacity, and in
accordance with the Ninth and Tenth Amendments to the Constitution of the
United States of America, and Article VI Clause 2 (Supremacy Clause), do
hereby affirm the following facts under penalty of perjury and sovereign oath:

I. DECLARATION OF IDENTITY

- 1.) I am a living, breathing woman, born on the land commonly referred to
as Killeen, Texas.
- 2.) I am known as Sharita Tameka Patterson, daughter of Rochelle Rene
Patterson and granddaughter of Ronald Clark Harwell, who is also the
son of Clark Harwell.
- 3.) I reside at:
[REDACTED], Newark, New Jersey 07104, [REDACTED]

II. ASSERTION OF TRIBAL LINEAGE

- 4.) I affirm my ancestral descent from the Navajo Nation, a federally recognized sovereign tribe.
- 5.) Although I do not currently possess a tribal enrollment ID or CDIB card, I assert my lineage based on oral tradition, genealogical inheritance, and familial ties recognized within the Navajo community and acknowledged in good faith under sovereign law.
- 6.) My ancestors—Ronald Harwell, Clark Harwell, and Rochelle Patterson—have passed down knowledge, heritage, and cultural principles consistent with Navajo traditions and tribal identification.

III. SOVEREIGN RIGHTS AND LEGAL AUTHORITY

- 7.) As a lineal descendant of the Navajo Nation, I invoke protections afforded by:
 1. Treaty of 1868 between the United States and the Navajo Nation,
 2. Indian Reorganization Act of 1934,
 3. 25 U.S. Code §§ 1301–1304 (Indian Civil Rights Act),
 4. 9th Amendment (protection of unenumerated rights),
 5. 10th Amendment (reserved powers to the People), and
 6. Article VI, Clause 2 of the U.S. Constitution (Supremacy of Treaties).
- 8.) I reserve the right to assert aboriginal title, land reclamation, and legal standing in any forum, including tribal, federal, or international venues, in accordance with the rights and spiritual obligations passed down through my bloodline.

IV. DEMAND FOR ACKNOWLEDGMENT AND RECOGNITION

- 9.) This affidavit shall serve as:
 1. A sworn public record of my heritage,
 2. A declaration of lineage for tribal and constitutional purposes, and
 3. A preliminary statement in support of land reclamation and restoration of ancestral dominion.

10.)Any party, agency, or official that seeks to deny this sovereign claim must present lawful rebuttal with equal or superior documentation, subject to full constitutional review.


