PERMANENT INJUNCTION is issued and shall stand as a final, unappealable command to
cease and desist from any and all:

Trespass

Claim of title

Lease enforcement- Occupancy

Business operation

Property management

Administrative interference

Corporate action or coercion

Use of fraudulent instruments or contracts

Harassment, threats, or retaliation against lawful heirs or tribal representatives

by [REDACTED], its members, shareholders, employees, agents, assigns, tenants,
contractors, or affiliates.

LAWFUL AUTHORITY FOR THIS INJUNCTION:

This injunction is enforceable under the following lawful authorities:

ORDERED INJUNCTIVE RELIEF:

IT IS HEREBY ORDERED, under the lawful authority of an Article III Constitutional Tribunal of Record: [REDACTED] its successors, assigns, occupants, or third-party agents are permanently enjoined from any activity on, about, or concerning [REDACTED]

Any present or future interference with the rightful possession of Sharita T. Patterson or her tribal agents shall result in sovereign enforcement, fines, liens, and immediate removal;

This order shall remain permanent, non-negotiable, binding, and shall be recorded publicly to prevent fraudulent conveyance or corporate claims;

Enforcement officers, sheriffs, or tribal marshals are authorized to immediately remove trespassers and secure tribal estate land.

AFFIDAVIT OF POSSESSION

REGARDING TRIBAL LAND CLAIM AND RIGHTFUL OCCUPATION

I, Sharita T. Patterson, Sovereign Woman of the Navajo Tribe, Empress of the House of Patterson, being of sound mind and lawful capacity, do hereby affirm, declare, and testify under penalty of perjury, under the laws of the Navajo Nation, the Constitution for the united States of America (1789), and in accordance with Title 28 U.S.C. § 1746, the following facts:

1. IDENTITY & STANDING:

I am the rightful tribal heiress and allodial titleholder of the private tribal estate located at:

[REDACTED], Newark, New Jersey Republic [07104]

[REDACTED], New Jersey Republic [07104]

I possess full lawful, spiritual, ancestral, and hereditary claim to said lands by divine birthright, tribal authority, and perfected allodial patent.

NATURE OF POSSESSION:

These lands are held in private trust as part of the House of Patterson and recognized under tribal land customs, traditional occupation, and international law. My claim has been publicly declared, perfected, and remains uncontested by any party with superior lawful title.

DEFAULT & UNLAWFUL OCCUPATION:

All former occupants, including those acting under or through [REDACTED], were issued Tribal Reclamation Notices, which have gone unchallenged. These parties are in default, and any presence upon the above properties is deemed unlawful trespass under tribal and treaty jurisdiction.

INTENT TO ENFORCE POSSESSION:

This affidavit shall serve as a lawful notice to all persons, corporations, and agencies that I maintain full, undivided, and inalienable possession of said tribal lands. Any interference, entry, or claim by outside parties is hereby prohibited, and subject to legal, tribal, and sovereign enforcement.
