

**PUBLIC - COMMON LAW NOTICE
AFFIDAVIT OF REVOCATION OF PATERNITY SIGNATURE FROM STATE ISSUE BIRTH
CERTIFICATE - REVOCATION OF STATE JURISDICTION**

I, Burton: of the Depestre Family, a living man, flesh and blood created by God, being first-hand witness and not a citizen, not a resident, not a subject or creature of any corporate state entity, make this notice of my own free will, without legal advice, under Almighty God, with clean hands, in good faith and full authority as the natural father of the 8 pounds 0 OZ male offspring known as Lance C. of the Depestre Family hereinafter "the child" born on the twenty second day of October of the year 2010 at 13:23PM in Hollywood, Florida at Memorial Regional Hospital a landmass part of North America.

I do hereby give notice of the following:

1. I, Burton of the Depestre Family, was induced to sign or give authorization for the creation of a State-issued Birth Certificate for the child, under conditions of stress, lack of full disclosure, fraud, and duress immediately following childbirth.
2. I had no knowledge that the said Birth Certificate was a commercial financial security instrument or bond used by the State as evidence of a contract, nor did I knowingly consent to any transfer of custody, property or jurisdiction to the State or any corporate agency.
3. Therefore, I hereby revoke, cancel, rescind and nullify any and all signatures, registration, informant status, or consent presumed to have been given with regard to the creation of such certificate or any trust, estate, or Ens Legis entity related to LANCE C DEPESTRE in all caps or any derivative thereof issued by the State, Nunc Pro Tunc, as if never signed. I do hereby reclaim my offspring as private property under common law, and I remove and revoke any claim of state jurisdiction over my child/offspring.
4. The child is private property of a living man's bloodline; the child was born alive, breathing the divine breath of life, and was not stillborn nor was lost at sea, abandoned, or under the control of any corporate or governmental entity and its offices or agencies. The child belongs to the private family trust of the living father Burton of the Depestre family and is not under the jurisdiction of any corporate STATE OF FLORIDA or UNITED STATES subdivision or Washington D.C. The child remains under the exclusive care, custody, and authority of the natural father, and all rights, responsibilities, and interests relating to the child are retained by the natural family.
5. Any claim by any State or its subdivisions that parental rights or custody belongs to them is repugnant to natural law, common law, and God's law, and is hereby lawfully refused. The undersigned living man is the only sole beneficiary and holder of parental authority over the living child.

Any use of my name or my child's name as surety for any commercial bonds, securities, or municipal financial instruments is hereby expressly revoked, rejected, and deemed null and void due to fraud, lack of full disclosure, coercion, and material misrepresentation. Any such unauthorized use will be subject to a fee or legal action by the trustees of the family trust.

6. Notice to agent is notice to principal. Notice to principal is notice to agent. I demand that any and all public record or presumption of State jurisdiction be immediately corrected and removed, and that my wishes as the living father and Grantor be honored without rebuttal.

-Under UCC 1-308, I reserve all my natural rights, waive no rights, and refuse any implied contracts with state agencies, including State Child Support Enforcement, any Courts, Peace Officers/Sheriffs, DOR, DCF or CPS and I do not consent to any undesired adhesion contracts or compelled performance.

-Executed under penalty of perjury under the laws of the Most-High and the common law, without the United States.



6. I retain all parental rights, responsibilities, and authority over said child and do not consent to any commercial contracts, registration, or surety arrangements made on his behalf without my expressed written consent or the family trust consent.
7. This Affidavit of Live Birth stands as lawful testimony and is issued in the private for any and all lawful purposes as may serve the protection of the child and our family estate.


