

- Failure to Cease and Desist Upon Notice: \$100,000 per 24-hour period
- Non-consensual Lien or Claim Against Trust Property: \$1,000,000 per attempt
- Obstruction of Trustee or Settlor Functions: \$50,000 per act
- Failure to Abide by Declaration or Schedule Provisions: \$25,000 minimum

All terms are enforced under common law, equity, and by private contract. Fees are non-negotiable and enforceable through lien, security interest, or judicial process as applicable.
