

AFFIDAVIT OF DENIAL OF U.S. CITIZENSHIP AND DECLARATION OF STATUS AS A FREE INHABITANT NATIVE MISSOURIAN/KANSASAN NATIONAL “but not a citizen of the United States”

NOTICE TO ALL AGENTS, OFFICERS, AND AUTHORITIES OF THE UNITED STATES GOVERNMENT AND ITS POLITICAL SUBDIVISIONS:

We, the undersigned, being of lawful age and competent to testify, do hereby solemnly affirm and declare:

1. **DENIAL OF U.S. CITIZENSHIP:** We are not, nor have we ever knowingly, voluntarily, or intentionally been, citizens of the UNITED STATES, a federal corporation as defined in 28 USC § 3002(15)(A). Any such presumption, registration, or administrative determination made without our express, informed, and written consent is hereby lawfully denied, rebutted, and revoked nunc pro tunc ab initio.
2. **BABY ACT PRESUMPTIONS VOIDED:** Any application of the so-called "Baby Act," presuming our consent to be wards of the STATE or citizens of the UNITED STATES due to birth or registration, is hereby revoked and denied. Birth on the land does not equate to citizenship under corporate rule or adhesion contracts not entered into knowingly and willingly.
3. **FREE INHABITANT STATUS:** We are Free Inhabitants as described in the Articles of Confederation (1777), Article IV:

"The free inhabitants of each of these States... shall be entitled to all privileges and immunities of free citizens in the several States."

4. **NATIVE MISSOURIAN/KANSASAN NATIONALS:** We are native to the land commonly known as Missouri and Kansas, born upon it by divine appointment and natural right, and claim our nationality accordingly. We are not subject to the Fourteenth Amendment nor to the jurisdiction of the United States federal corporation or its subsidiaries.
5. **RIGHTS RESERVED:** All unalienable rights are hereby reserved pursuant to UCC 1-308 and UCC 1-103.6, including the right to travel, contract, own property, and live free from compelled performance or statutory obligations.
6. **NO POWER OF ATTORNEY GRANTED:** We revoke, rescind, and deny any power of attorney granted implicitly or explicitly to any agency, administrator, court, or officer acting under color of law.
7. **LAWFUL DECLARATION AND PUBLIC NOTICE:** This Affidavit is made under penalty of perjury, under common law, and with full capacity. Let this serve as lawful

public notice to all entities and agents that we do not consent to United States citizenship, taxation, compelled benefits, or any jurisdiction not expressly contracted into.
