The original Assignor signed form 56. After three (3) days, a copy of the accepted or rejected contract is required to be returned to the Assignor. Upon acceptance, it is then under the 3-day Rule of Law to have this matter resolved or settled with all remaining residue returned to the Assignor.

As the Assignee of this fiduciary action, you are now under a form of exposure to the law that is needed to bring about the resolution and settlement of the above-identified court case under maritime, commercial, and civil law for the proper disposition of the residue.

This fiduciary action is the original lessor's demand for rent due from the government lessees per the government's maritime commercial monetary securities addressed in this admiralty case by this Office and the Flag of Land Admiral, the maritime Executor also known as the original Assignor / Re-Assignor / Assertor.
