The property list in the collateral section, field 4, should be adjusted to your actual property (your house, your car, your boat, your trailer, et cetera). Edit for your own property list.

You can use a site like gps-coordinates.net to convert an address into latitude and longitude coordinates.

Line 1c (Debtor's Address: This address may be the Vital Statistics office, the birth hospital address, your mailbox address (where the trust operates), or just another address different from line 2c.

The bill of sale number is the number from your Bill of Sale doc which you used to transfer property to the trust corpus.

After your filing is complete, and you have a U.C.C. number, follow the state's instructions to obtain a certified copy of your UCC-1.

You may choose to amend this statement with a UCC-3. For example, you might add a bill of exchange number that you sent to a company or a court case number to make a claim on securities in the LEGAL NAME established in your likeness.
